

Overview

Segal Marco Advisors maintains a proprietary scorecard that evaluates the sustainability policies and practices of equity, fixed income, and alternatives investment managers.

The results provide Segal Marco and its clients with a touchstone to benchmark and compare different investment strategies and managers, as well as a process to measure progress over time. Segal Marco introduced the the Sustainability Ratings in 2022.

Methodology

Segal Marco Advisors requests that its recommended managers complete an annual questionnaire on the firm's sustainability policies and practices. Recommended managers are those that prevailed through Segal Marco's Seven Principles due diligence process for evaluating investment managers and strategies.

The questionnaire covers practices and policies for each rated strategy. Questions focus on the integration of sustainability issues within the investment process and practices, as well as team expertise, affiliations and organization.

Segal Marco's Sustainable Investing Committee conducts the survey on behalf of the firm. The Committee is charged with integrating sustainability issues and perspectives across Segal Marco's operations and manager due diligence functions.


Scoring and tiers

Each investment strategy is assigned an individual score based on responses to the questionnaire. The strategy's score then determines its rank among three tiers based on a comparative review of all managers in each asset class. Equity managers are also tiered on a comparative review relative to each sub-asset class (i.e., Large Cap, Mid Cap, Small Cap, International, etc.).

The tiering is determined through statistical analysis. Parameters for each tier are set following a normal distribution; managers that score one standard deviation or more above the mean rank in Tier 1, managers that score one standard deviation or more below the mean rank in Tier 3, and any manager to score within one standard deviation above/below the mean rank in Tier 2.

Relative ranking

Through Segal Marco Alpha Research's dedicated due diligence process, managers and strategies are evaluated within the Seven Principles framework. Embedded within the principles and processes, managers are evaluated on Sustainability practices through a qualitative lens. The Sustainability Rating enhances the due diligence process to provide a relative ranking on a firm and strategy's approach to sustainability for those clients seeking best-in-class sustainability performance.
